SECTION 3

REGULATIONS for Brush & Log Collection Program

For scheduling purposes, the Township has been divided into 4 sections; your residence is in Section 3, the section you are in will remain the same for all curbside removal programs performed by the Department of Public Works.

Brush and Log collection this spring is scheduled to begin the week of April 14th. Residents should have their brush and logs **ON PAVED ROADWAY BUT NOT MORE THAN 3' INTO PAVED ROADWAY (measured from curb, if no curb exists measure from where the pavement begins)** no earlier than 7 days prior to the following dates: (please have all material out for removal before 7:00am on the Monday of the scheduled week of collection)

1. Branches and logs are to be placed in separate untied bundles or piles. A maximum total of three (3) piles of materials (branches and logs) may be put out for any scheduled collection.
2. Branches must be cut no longer than three (3) feet in length and be a maximum of four (4) inches in diameter.
3. Logs must be cut no longer than three (3) feet in length and be a maximum of six (6) inches in diameter.
5. Logs greater than 6" in diameter are the responsibility of the resident to remove.
6. Piles of branches and logs put out for collection shall be no longer than three (3) feet in length, three (3) feet in width, and three (3) feet in height.
