A meeting of Princeton Township Committee and Princeton Borough Council was held on this date at 7:30 p.m. in the council room of the Princeton Borough Hall, 1 Monument Drive to discuss the Joint Municipal Budgets.

Present: Mayor Trotman, and Mesdames Crumiller and Trelstad, Messrs. Goldfarb, Koontz, Martindell and Wilkes.

**Animal Control**

Mr. Koontz offered a motion approving the Animal Control budget for 2010. Mr. Goldfarb seconded the motion as presented. The motion was carried unanimously by the Borough.

Mayor Miller offered a similar motion on behalf of Princeton Township. The motion was seconded by Mr. Goerner and carried unanimously.

**Corner House**

Mr. Koontz offered a motion approving the Corner House budget for 2010. Mr. Martindell seconded the motion as presented. The motion was carried unanimously by the Borough.

Mr. Liverman offered a similar motion on behalf of Princeton Township. The motion was seconded by Ms. Lempert and carried unanimously.

### **Environmental Commission**

Mr. Wilkes offered a motion approving the Environmental Commission budget for 2010. Mr. Martindell seconded the motion as presented. The motion was carried unanimously by the Borough.

Ms. Lempert offered a similar motion on behalf of Princeton Township. The motion was seconded by Mr. Liverman and carried unanimously.

### **Fire Department and Fire Facilities**

Mr. Goldfarb offered a motion approving the Fire Department and Fire Facilities budget for 2010. Mr. Martindell seconded the motion as presented. The motion was carried unanimously by the Borough.

### **First Aid**

Mr. Koontz offered a motion approving the Rescue Squad budget for 2010. Ms. Trelstad seconded the motion as presented. The motion was carried unanimously by the Borough.

Mr. Goerner offered a similar motion on behalf of Princeton Township. The motion was seconded by Mr. Liverman and carried unanimously.

### **Health Department**

Mr. Koontz offered a motion approving the Health Department budget for 2010 as proposed. Ms. Trelstadt seconded the motion as presented. The motion was carried unanimously by the Borough

Mr. Liverman offered a similar motion on behalf of Princeton Township. The motion was seconded by Ms. Lempert and carried unanimously.

### **Library**

Mr. Koontz offered a motion approving the Library budget for 2010. Mr. Goldfarb seconded the motion as presented, which was carried unanimously by the Borough.

Mr. Goerner offered a similar motion on behalf of Princeton Township. The motion was seconded by Ms. Lempert and carried unanimously by the Township.

### **Planning**

Mr. Goldfarb offered a motion approving the Planning budget for 2010. Ms. Crumiller seconded the motion as presented, which was carried unanimously by the Borough.

Mr. Goerner offered a similar motion on behalf of Princeton Township. The motion was seconded by Ms. Lempert and carried unanimously by the Township.

### **Recreation**

Ms. Trelstadt offered a motion approving the Recreation budget for 2010. Mr. Koontz seconded the motion as presented, which was carried unanimously by the Borough.

Ms. Nemeth offered a similar motion on behalf of Princeton Township. The motion was seconded by Ms. Lempert carried unanimously by the Township.

### **Sewer Operating Committee**

On behalf of the Township, Mr. Liverman offered a motion to approve the proposed budget for 2010. The motion was seconded by Mr. Goerner and carried unanimously.

Ms. Trelstad offered a similar motion on behalf of the Borough. The motion was seconded by Mr. Goldfarb and carried unanimously.

### **Solid Waste**

Ms. Nemeth offered a motion on behalf of the Township to approve budget for solid waste for 2010. The motion was seconded by Ms. Lempert and carried unanimously.

Mr. Koontz offered a similar motion on behalf of the Borough. Mr. Wilkes seconded the motion, which was carried unanimously.

### **Human Services**

Mr. Liverman said that Human Services is note worthy and also worthy of tax payer dollars. He said that they offer remarkable services and that he would be in favor of a review. Mr. Liverman said that it really bothered him to have to defend this agency. Mr. Goerner said that he agreed with Mr. Liverman

and thanked Borough Council for the opportunity to review. Mayor Miller said that Princeton prides itself on being progressive and when times are tough, they are tougher on those with no protection.

Mr. Goldfarb said that there are any number of private agencies who provide the same services as Human Services and they do them better. He said he could not support them with his vote.

Mr. Koontz offered a motion on behalf of Princeton Borough approving the Human Services budget as presented. Mr. Wilkes seconded the motion which was carried by four affirmative votes. Mr. Goldfarb and Mr. Martindell voted in the negative.

Mr. Goerner offered a similar motion on behalf of Princeton Township. The motion was seconded by Mr. Liverman carried unanimously

**Suzanne Patterson Center**

Mr. Liverman offered a motion to approve the 2010 operating budget for the Suzanne Patterson Center. Ms. Lempert seconded the motion for the Township, which was carried unanimously.

Mr. Wilkes offered a similar motion on behalf of the Borough. Mr. Koontz seconded the motion, which was carried unanimously.
